EVICTON BOOKING PROCESS

- This form must be completed and emailed to the EOC as soon as possible via eoc@justice.nsw.gov.au.**
- Payment of the eviction must be made as soon as possible to the EOC via the Simple Payment Portal (SPP).
- A secure payment link will be sent to your nominated email address once this form has been received.
- An email will be sent to your nominated email address confirming the scheduled date and time of the eviction.**

INFORMATION FOR AGENT, LANDLORD OR REPRESENTATIVE

- The completed form and fees should be made available to the EOC as soon as possible. Any delay in submitting this form or payment of fees may result in the requirement for a further warrant or writ to be issued.
- Agents, landlords and/or representatives must:
 - Organise a locksmith to attend at the date and time of the eviction
 - Bring all available keys for the premises
 - DO NOT enter the premises or engage with the occupants/tenants prior to Sheriff's Officers arriving and clearing the property
 - Advise the EOC via phone or email as soon as possible of any changes or concerns relating to the eviction or occupants/tenants
 - Receive a receipt of possession upon completion of the eviction process
 - Refer to Fair Trading NSW for further information relating to uncollected goods left at the premises
 - Refer to Council Rangers relating to animals left at the premises
- Refer to NSW Police in relation to any Trespassing enquiries following the eviction.**
